4. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
5. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
6. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.
7. It will continue to pay Annual Fee of Rs. 5000/- p.a. The schools run by KV/NVS/CTSA/Govt./Govt. Aided/Railways/Armed forces etc. are granted regular affiliation and apply online for Extension of Affiliation through link provided on Board website www.cbseaff.nic.in. under the Government Schools Corner.
